Please review the City Gym rules with your student:

No alcohol, smoking, illegal drugs, weapons, or vandalizing.

No improper behavior, gestures, or language

No food or beverages on the gym floor or racquetball court

No black marking shoes on the court

No unsportsmanlike conduct will be tolerated

Any person who misuses the City Gym facilities or equipment engages in misconduct on or about the facilities or engages in conduct disruptive to programs being held at the facilities, whether or not in connection with an event sponsored by the Parks Department, shall be subject to having their City Gym privileges revoked at the sole discretion of the Superintendent of the Parks Department for the City of Bluffton.

Open gym is typically from 3:30-6 pm every Monday, Thursday, Saturday, and Sunday, November – mid-March. Gym calendars are posted on the city's website at <https://teamup.com/kshe54y9g2zc9mykm8>. This supervised gym time is for students in K-12th grade only. Adults are not allowed on the gym floor and may not coach their children from the stands. Please pick your child up promptly by 6 pm.
